
Industrial producer prices up by 0.7% in euro area

Up by 0.9% in EU28

In December 2016, compared with November 2016, industrial producer prices rose by 0.7% in the **euro area** (EA19) and by 0.9% in the **EU28**, according to estimates from **Eurostat, the statistical office of the European Union**. In November 2016 prices increased by 0.3% in the **euro area** and by 0.2% in the **EU28**.

In December 2016, compared with December 2015, industrial producer prices rose by 1.6% in the **euro area** and by 2.4% in the **EU28**.

The average industrial producer price for the year 2016, compared with 2015, decreased by 2.3% in the **euro area** and by 1.9% in the **EU28**.



Monthly comparison by main industrial grouping and by Member State

The 0.7% increase in industrial producer prices in total industry in the **euro area** in December 2016, compared with November 2016, is due to rises of 2.1% in the energy sector, of 0.4% for both intermediate goods and non-durable consumer goods and of 0.1% for capital goods, while prices remained stable for durable consumer goods. Prices in total industry excluding energy rose by 0.3%.

In the **EU28**, the 0.9% increase is due to rises of 2.7% in the energy sector, of 0.4% for intermediate goods, of 0.3% for non-durable consumer goods and of 0.1% for both capital goods and durable consumer goods. Prices in total industry excluding energy rose by 0.3%.

The highest increases in industrial producer prices were registered in **Greece** (+2.7%), the **Netherlands** (+2.1%), **Croatia** (+1.8%), **Belgium** and **Portugal** (both +1.7%), while decreases were observed in **Estonia** (-0.6%), **Ireland** (-0.5%) and **Denmark** (-0.2%).

Annual comparison by main industrial grouping and by Member State

The 1.6% increase in industrial producer prices in total industry in the **euro area** in December 2016, compared with December 2015, is due to rises of 3.9% in the energy sector, of 1.2% for non-durable consumer goods, of 0.8% for both intermediate goods and durable consumer goods and of 0.6% for capital goods. Prices in total industry excluding energy rose by 0.9%.

In the **EU28**, the 2.4% price increase is due to rises of 7.2% in the energy sector, of 1.3% for non-durable consumer goods, of 1.0% for both intermediate goods and capital goods and of 0.9% for durable consumer goods. Prices in total industry excluding energy rose by 1.1%.

The largest increases in industrial producer prices were registered in **Belgium** (+8.0%), the **United Kingdom** (+7.2%) and the **Netherlands** (+5.5%), while decreases were observed in **Luxembourg** (-6.1%), **Slovakia** (-1.8%), **Latvia** (-1.5%), the **Czech Republic** and **Slovenia** (both -0.3%).

Geographical information

The **euro area** (EA19) includes Belgium, Germany, Estonia, Ireland, Greece, Spain, France, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Austria, Portugal, Slovenia, Slovakia and Finland.

The **European Union** (EU28) includes Belgium, Bulgaria, the Czech Republic, Denmark, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Hungary, Malta, the Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Finland, Sweden and the United Kingdom.

Methods and definitions

The **index of producer prices** shows (in the national currency of the country concerned) changes in the ex-works sale prices of all products sold on the domestic market, excluding imports. Euro area and EU indices refer to overall weighted price changes. The figures are not calendar day or seasonally adjusted.

Total industry covers NACE rev.2 sections B to D + E36.

Revisions and timetable

Compared with data issued in the News Release 2/2017 of 5 January 2017, the monthly percentage change for November 2016 remains unchanged at +0.3% in the euro area and has been revised from +0.3% to +0.2% in the EU28. The annual percentage changes remain unchanged at +0.1% in the euro area and at +0.7% in the EU28.
